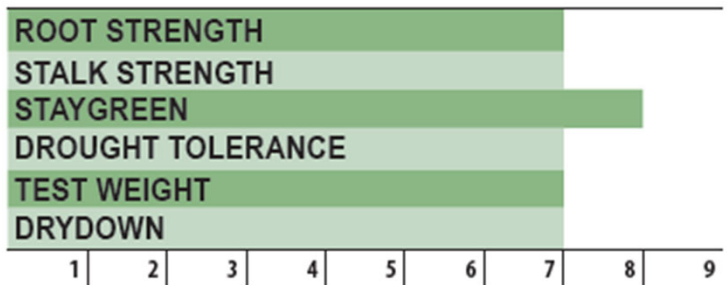

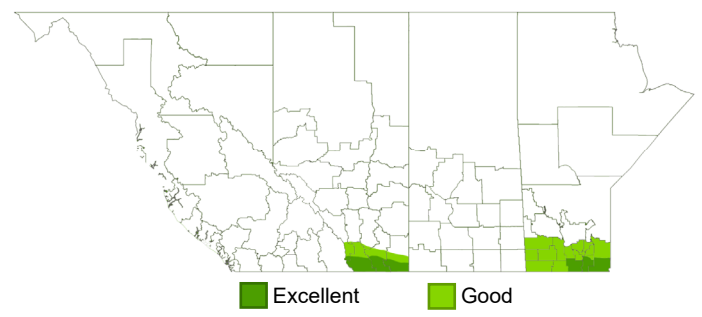

Area of Adaptation



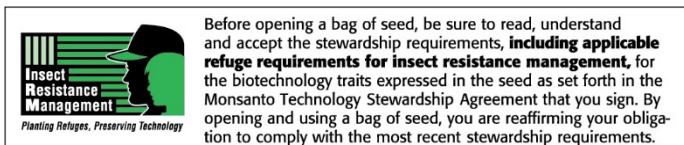
